

**Saint Charles County Summer Swim League**  
**February 10<sup>th</sup>, 2009**  
**Meeting Minutes**

The league meeting was called to order at 6:34pm by league director, Rob Lechner. Roll call was taken by Jim Schlueter. All teams were present except Blanchette and Laurel Park. According to the bylaws, a quorum was present.

Minutes from the February 10, 2008 meeting were reviewed. A motion was made by Pearson Buell (LSL) and seconded by Joe McDonald (Wentzville) to approve the minutes. All teams represented approved the minutes.

Tammie Schneider, league treasurer, provided a treasurer's report. The league's internal statements balanced with the bank statements. Handouts of the 2008 season summary and the 2009 treasurer's report were reviewed. As of 2006, the league is no longer recognized by the Secretary of State of Missouri. Tammie is looking to the paperwork required to file with the state. A question was asked about fees and penalties that may be applied by the state due to the lapse. Tammie will be looking into this.

Rob introduced the members of the board. Tammie Schneider is the league treasurer, Jim Decker is the assistant league director, and Jim Schlueter is the league treasurer. Rob's intention is to keep the meeting times to one hour or less. In an effort to keep meetings short, groups may need to be formed to address issues.

Lisa Ritter and Pam \_\_\_\_\_ are all county directors. Terry Eberwine is replacing Allison Volk as the assistant all county director.

Julie from Kids Sports World will have fittings at a location requested by each team. Kids Sports World is located in Chesterfield off of Clarkson Road. A team will be assessed a \$5 per swimmer fine if Kids Sport World is not used as the swimsuit vendor.

Scheduling

Meet schedules and other events will be addressed at the meeting in March. The schedule will be voted on at the April meeting. Steve Glogoza has software that will assist in scheduling the meets.

Rules

The league will adhere to the National Association of State High School rules. The rules can be downloaded for \$25. Joe McDonald offered to help get the rules.

#### Stroke Judges

A location is needed to offer a stroke judge clinic. All teams appear to have enough stroke judges except for the Vineyards. Current stroke judges will be posted on the web. Stroke judges are current if they have attended a stroke clinic within three years.
