

SAINT CHARLES COUNTY SUMMER SWIM LEAGUE STROKE JUDGE CLINIC

To All Stroke Judges:

The SSCSSL will again be hosting a Stroke Judge Clinic for the 2011 summer season. The purpose of this clinic is to provide certified stroke judges for the Summer Swim League, as required by our By-Laws. It is recommended that every team have at least six certified stroke judges, as each team is required to have a minimum of two stroke judges with current certification at every meet for the entire duration of the meet. Please keep in mind that stroke judge certification must be renewed at least every three years. A list of current certified stroke judges for each team may be found on the league web site. Please review your team's list for accuracy and to verify how many of your currently certified stroke judges are returning for the 2011 season or need to renew their certification.

For your convenience, we are hosting two clinics, the first on Saturday morning May 21st from 9-11 am. The second is on Thursday, June 2nd from 7-9 pm. Please choose the clinic that best meets your schedule. We ask that you arrive a bit early so that we can get started on time. Signs will be posted in the Community Association clubhouse indicating the meeting room for the clinic. This certification lasts for a period of three years. The clinics will be hosted as follows:

Driving Directions:

From I-70

Exit at LSL Blvd (exit 214)
Right on Veterans Memorial Pkwy (S. Service Road) - Go about 1.24 miles
Left on Deloire Dr.
Left on Savoy Drive
Right on Rue Grand (at stop sign)
Right on Cognac Court (at stop sign)

From I-64 (westbound)

Exit at Lake Saint Louis Blvd
At stop light at top of ramp, continue straight on Civic Center Drive
Right on Dauphine Drive (right after you pass over the lake/creek bridge) - go 1.08 miles
Left on Cognac Drive, becomes Cognac Court - straight ahead

From I-64 (eastbound)

Exit at Prospect
Take left over I-64
Right on Prospect (at roundabout)
Prospect turns into Picardy when it crosses Freymuth, continue on Picardy
Right on Rue Grand
Left at Cognac Court - straight ahead

Additional Parking:

Proceed past Clubhouse on Rue Grand (passing Cognac Ct. from I-70, or turning left on Rue Grand from Highway 40).
Right on Ardennes.
Right on Champagne. Parking lot is on the right just past the tennis courts.
