

Saint Charles County Summer Swim League
March 10th, 2009
Meeting Minutes

The league meeting was called to order at 6:34pm by league director, Rob Lechner. Roll call was taken by Jim Schlueter. All teams were present.

Rob Lechner reintroduced the board.

Minutes from the February 10, 2009 meeting were reviewed.

Names for director positions are needed. The following teams are responsible for the given positions:

Treasurer's Report

We still have not received the most recent statement from the bank. There has been no activity since the last statement.

We will be re-registered with the state. The total cost to re-register is \$85. This includes a \$20/year fee and a \$25 fee. We owe fees for three years ($\$20/\text{year} \times 3 \text{ years} = \60).

We owe no taxes.

The annual cost of the website was reduced from \$80 to \$70.

We still need to renew our insurance. American Family will not cover our league. There are two brokers looking into coverage. Michelle Relling was given as a name of a broker. A decision will be made by Tuesday, March 17th as to who will provide insurance.

Ribbon Orders

We have last year's orders – most teams will order the same quantities.

The cost of ribbons went up to \$0.16 from \$0.15.

A number of teams placed orders for participation ribbons.

New Business

Bylaw Modification

Rob Lechner proposed a change to the bylaws to read

Pearson Buell nominated approval of the proposal. Paul York seconded it. It was unanimously approved.

Stroke Judge Clinic
